Enclosed is the State Pollutant Discharge Elimination System (SPDES) Permit for the referenced facility authorizing a treated industrial discharge and treated sanitary discharge to a surface water. The treated discharges authorized by the permit must be undertaken in compliance with applicable provisions of New York State Department of Environmental Conservation's (DEC) regulations at 6NYCRR 750-2. You may access Part 750 on the DEC website at https://dec.ny.gov/regulatory/regulations/chapter-x.

Please read the permit and Part 750 carefully and become acquainted with their content. Please note that this SPDES permit is for the treated discharges specified in the permit and does not convey nor imply any other approvals.

As the holder of this SPDES permit, you are responsible for the payment of an annual regulatory fee. Any questions regarding this annually billed fee should be addressed directly to the Regulatory Fee Determination Unit at (518) 402-8210.

By copy of this letter, I have notified the New York State Department of Health that the SPDES permit has been issued and of its contents.

Also enclosed is your 6 NYCRR Part 608 Protection of Waters permit for construction. It is essential that you give particular attention to the Notice/Permit Sign enclosed with your permit and to the Conditions. The attached plans are also a part of the permit. You must print the Notice/Permit Sign, post it in a conspicuous location, and protect it from the elements during construction of the outfall on the bank of the power canal.



The Responsiveness Summary enclosed identifies conditions in the final SPDES permit that are different from the conditions in the draft permit and the reasons for the changes. The Responsiveness Summary also addresses relevant comments received during the public comment period, including comments made by Air Products.

Be advised, the Uniform Procedures Regulations (6 NYCRR Part 621) provide that an applicant may request an adjudicatory proceeding if a permit is denied or contains conditions which are unacceptable to them. Any such request must be made in writing within 30 calendar days of the date of permit issuance and must be addressed to the Regional Permit Administrator at the letterhead address. A copy of the request must also be sent to the Chief Administrative Law Judge, addressed to Chief Administrative Law Judge, NYSDEC, Office of Hearings and Mediation Services, 625 Broadway, Albany, NY 12233-1550.

The electronic copies of the permits will be the only copy you will receive. We will not mail a hard copy to you.
